

DETAILS OF WORK

On May 22, 1959 we ran 2064' (76 Joints) of 7" OD 10-V 24# used seamless casing to 2067' and cemented with 150 sacks cement.

After standing cemented for 72 hours, we pressured up on casing to 3000 psig. We then drilled plug, bailed hole down and re-ran bailer.

As shut-off proved complete drilling was resumed.

Cementing and pressure testing was done by Denton Oil Well Cementing Company.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
