Instructions

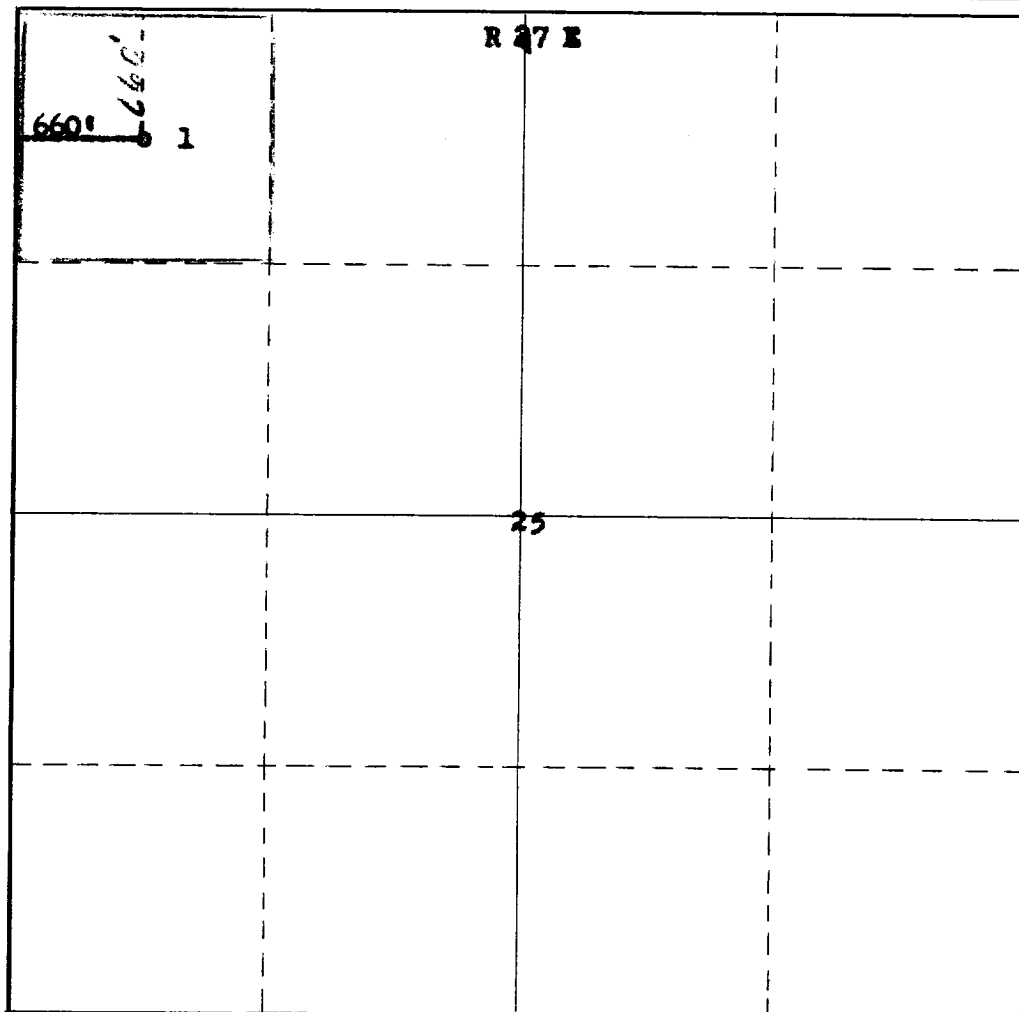
