T.D. 13220' Dolomite. Plugged and abandoned. This well was plugged and abandoned in the following manner:

1. RIH w/open ended DP and spotted an 85 sack Class H cement plug @ 11274 - 11074' (200'), across the top of the Morrow Formation. LDDP to 8460'.
2. Spotted an 80 sack Class H cement plug @ 8460 - 8295' (165'), across the top of the Wolfcamp Formation. Circ. 4 hrs. Tagged top of plug @ 8360'. Spotted a 28 sack Class H cement plug @ 8360 - 8299' (61'). LDDP to 6294'.
3. Spotted a 20 sack Class H cement plug @ 6294 - 6144' (150'). LDDP to 4096'.
4. Spotted a 60 sack Class H w/2% CaCl₂ cement plug @ 4096 - 3896' (200'), 1/2 in and 1/2 out of the 8-5/8"OD casing shoe @ 4044'. Circ. 2 hrs. Tagged top of the plug @ 3896'. LDDP to 650'.
5. Spotted a 35 sack Class H cement plug @ 650 - 550' (100'), 1/2 in and 1/2 out of the 13-3/8"OD casing shoe @ 575'. LDDP.
6. ND BOP'S and wellhead. CO casinghead. Spotted a 15 sack cement surface plug @ 50 - 0'. Welded top of 8-5/8" casing and installed a 4" dry hole marker to designate a plugged and abandoned location.

This plugging procedure was given prior verbal approval by the BLM office at Roswell, New Mexico and was witnessed by Mr. John Wade of the same office.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
