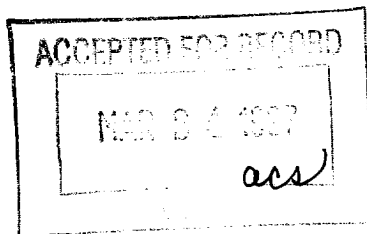

Spudded this well on 2/23/97 at 1400 hrs and drld a 12 1/4" hole to 1067'. On 2/25/97 ran 26 jts 8 5/8" 24# J-55 ST&C csg, set at 1066'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 83 sxs cmt.

Drld 7 7/8" hole and reached TD 2550' on 1/13/1/97 at 0100 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 61 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2549'. Cemented w/150 sx lite "C" + 500 sx Class "C". Circ'd 9 sxs cmt.

Released rig at 2200 hrs 3/2/97. WOCU.
