Spudded this well on 3/30/97 at 1500 hrs and drld a 12 1/4" hole to 1065'. On 4/1/97 ran 26 jts 8 5/8" 24# J-55 ST&C csg, set at 1064'. Cemented w/100 sxs cl "C", 300 sx lite "C" & tailed w/200 sx Class "C". Circ'd 10 sxs cmt.

Drld 7 7/8" hole and reached TD 2650' on 4/3/97 at 1700 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 63 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2649'. Cemented w/225 sx lite "C" + 250 sx Class "C". Cmt did not circulate. Pump pressure indicates cmt near surface.

Released rig at 2400 hrs 4/4/97. WOCU.
