Will drill with Fort Worth Jumbo J Spudder (cable tools) to and thru 1920'-1980' oil and gas horizons and/or as they may correspond and correlate with wells #2 and #3, drilled in this well No.7 and run 8-5/8" OD (8-1/2" I.D.) casing -24 lbs. to top of salt around 500 ft and cement same with 50 sacks of cement. The cement will be allowed 72 hours to set before drilling is resumed. After the pay has been found, will submit notice or obtain verbal approval for 7" O.D. (6-5/8" I.D.) casing - 20 lbs.- casing point, after which said 7" casing will be set and cemented with at least 100 sacks of cement with heavy mud pumped ahead.

Instructions
