Well is currently producing from 3538 - 50'. We propose to set a CIBP at 35<sup>35</sup> and perforate the Grayburg from 3337' - 3474' gross interval, acidize with 2000 gallons, frac with 50,000 gallons gelled H<sub>2</sub>O carrying 130,000# 16/30 sand.
