- Pull rods & tubing. Move off pulling unit.
- Perforate zones of interest w/one 3/8" jet per interval:
Lovington Sand, 2557, 2548, 2538, 2525, 2519 Anderson Zone 3, 2333, 2328
Premier Sand, 2411, 2408, 2405, 2402 Anderson Zone 2, 2318
Anderson Zone 6, 2398 Anderson Zone 1, 2301, 2295
Anderson Zone 5, 2374 Metex Zone 2, 2278, 2266
Anderson Zone 4, 2360, 2355
Set retrievable bridge plug & wireline between oolitic & Lovington Zones.
- Frac down csg. w/50,000 gals. gelled water & 75,000# 20-40 Sand. Overflush w/10 BW.
- Shut-in a minimum of 12 hours.
- Bleed off pressure, run tbg. w/retrievable head & recover bridge plug.
- Run tbg. & rods and put on pump.
