Propose to set 30' of 13-3/8" conductor pipe and cement to surface with ready-mix cement. Drill 11" hole to top of salt at 540' and 7-7/8" hole to total depth of 2780'. Run 5-1/2", 14#, J55 casing to total depth and cement to surface with approximately 700 cu. ft. cement.
