- Well spudded at 8:00 A. M. 4-17-71.
- Ran 446' KB 8-5/8" 20# casing as follows:
 - Volume of cement equalled 132 cubic feet (100 sacks).
 - Brand of cement was Southwestern Class C with 2% CaCl.
 - Approximate temperature of cement slurry 65°F.
 - Formation temperature 65°F.
 - After standing cemented for 9 hours compressive strength was 800#. Pressure tested to 400#. Tested OK.
 - Drilled out cement after standing 12 hours.
- Ran 3299' KB 5-1/2" 14# casing and cemented with 300 sacks cement.
- We perforated at follows: 2498'-2502', 2540'-2550', 2572'-2574', 2618'-2623', 2924'-2926', 2946'-2950', 2963'-2965', 3027'-3030', 3047'-3051', 3060'-3062', 3230'-3240'.
- We fraced the Matex Sand with 40,000# SD and 40,000 gals gelled water. The Grayburg Dolomite was acidized with 3,000 gals 20%. The San Anders was acidized with 6000 gals. 20% and fraced with 40,000# SD and 40,000 gals gelled water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
