Ran surface csg as follows: 11 jts, 8 5/8", 24#, J-55, ST&C, 449.67'. Guide shoe @ 464'.

Cemented csg as follows: Lead - 300 sx PSL "C" + 6% gel + 2% CaCl₂ + 1/4 lb/sk celloseal, (wt 12.7 ppg, yield 1.86 cft/sk). Tail - 200 sx Class "C" + 2% CaCl₂, (wt 14.8 ppg, yield 1.32 cft/sk).

Circ'd cmt to surface.

Reached TD of 3770' on 6/10/96.

Ran production csg as follows: 88 jts 5 1/2", 15.50#, J-55, LT&C. Float shoe @ 3769', float collar @ 3727'. Top - 78 jts, 3349.23'; middle - 1 jt, 37.13'; & bottom - 9 jts, 383.78'.

Cemented csg as follows: Lead - 650 sx PSL "C" + 4% gel + 5% salt + 1/4 lb/sk celloseal, (wt 13 ppg, yield 1.76 cft/sk). Tail - 350 sx Class "H" + 10% Gypsum + 1/4 lb/sk celloseal, (wt 14.5 ppg, yield 1.52 cft/sk). **Circ'd cmt to surface.**
