Ran and cemented 42 joints of 8 5/8" 24# J-55 new seamless Spang casing with 500 sax of cement. Cement did circulate. WOC 48 hours. Nippled up blowout preventer and drilled out. Tested pipe and cement with 1,500# pressure. Casing and cement tested OK.
