On 9-9-59 11" hole was spudded and drilled to a depth of 1480'. On 9-13-59, sufficient 8-5/8" OD 8R 24# J-55 casing was run and set at 1480' with 900 sx cement, circulated. After WOC 48 hours tested with 1000 PSI. Tested OK Reduced hole to 7-7/8" at 1480' and resumed drilling operations.
