On 9-30-59, 4-1/2" 9.5# J-55 Casing was run and set at 5695' with 650 Sx. 8% Gel & 100 Sx neat with equal parts pozmix S. Top cement 975', Temperature Survey. After WOC 24 hours pump tested casing with 3800 PSI. for 30 minutes, with no loss in pressure. Completion operations resumed.
