On September 16, 1959, a survey was made to locate your U. S. A. Malco Refineries, Federal "H", Royalty Account "E", No. 7 oil well to a point 660 feet from the east line and 646.63 feet from the north line of Section 3, Township 18 South, Range 27 East, New Mexico Principal Meridian, Eddy County, New Mexico.

A flag was placed on the east quarter corner of Section 3, and the transit was placed over the point common to Section 3, 4, 9, and 10 of the above mentioned Township and Bange. We then chained south 0 degrees, 51 minutes east a distance of 646.63 feet to a point marked by a 2 inch by 2 inch wood hub with a tack; thence south 89 degrees, 53 minutes west a distance of 660 feet to the location marked by a $\frac{1}{4}$ inch steel pin. To check we then chained back to the above mentioned wood hub; thence south 0 degrees, 51 minutes east a distance of 1987 feet to the east quarter corner of Section 3 for a closure error of less than 0.30 feet.
