Will pull existing tbg, clean out to TD, run GR-Neutron log, run and set 4½" (9.5#) csg @1991', and cement w/250 sx cmt. Estimated top of cmt 1500'. Will perforate pay zones 1897' to 1991' with 3 shots/ft. Will run 2" cmt lined tbg and set at 1850' on tension pkr.
