Dear Sir:

By this letter we are asking for an exception to Rule 104 of the Oil Conservation Commission for an unorthodox location of a well which we propose to drill in the NE/4 SW/4 SE/4 of Section 26, Township 18 South, Range 27 East, Artesia Pool, Eddy County, New Mexico.

Because of the rough terrain along the border line of the escarpment, which runs through the SE/4 of Section 26, we would appreciate the administrative approval of a location 1060 feet from South line and 1560 feet from East line of Section 26 as shown by surveyors plat enclosed herein. The proposed location will save us considerable expense over a 330 foot location.

We have enclosed waivers from the two offset lease owners involved, Realer Oil Company to the North and S.P. Yates Drilling Co. and John A. Yates to the East, whereby Realer Oil Company states that they have no objection to this well being drilled closer than 330 feet from the North line of this forty acre tract, and S.P. Yates and John A. Yates state that they have no objection to the drill site being located 230 feet from the East line of the forty acre tract.

If this request is approved, will you kindly mail one copy to United States Geological Survey at Artesia, New Mexico.
