

Plan to drill this to approx. 2680' or to sufficient depth to test the Loco Hills sand. Plan to run and cement approx. 450' of 8 5/8" 24 # surface pipe and approx. 2680' of 7" 20# oil string of casing. Plan to diamond core the Loco Hills section. Plan to gun perforate the 14 oil string into the Loco Hills section and hydrofract same with 10,000 gal. oil and 15,000 sand.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
