10-12-2000 - Moved in and rigged up pulling unit. Pumped 40 bbls 2% KCL. Nippled down tree and nipped up BOP. Released packer. TOOH with packer and 2-3/8" tubing.

10-13-2000 - Rigged up wireline. TIH with gauge ring to 9050'. TOOH with gauge ring. TIH with CIBP and set CIBP at 9000'. Capped CIBP with 35' of cement. Rigged down wireline. Loaded casing with 140 bbls. Casing would not hold pressure. TIH with packer and tubing to attempt to find hole in casing. Tested casing down to 8400' - no holes. Shut in overnight.

10-14-16-2000 - Continued testing casing. Found bad casing from 8926-8666'. Pulled up to 7800'. Shut down.

10-17-2000 - Rigged up wireline. TIH with CIBP at set CIBP at 8600'. TOOH. Tested CIBP to 500 psi. TIH with 4" casing guns and perforated 7640-7660' w/21 .42" holes (1 SPF - Canyon). TOOH with casing guns and rigged down wireline. TIH with packer and tubing. Set packer at 7585' and tested, OK. Acidized perforations 7640-7660' with 2500 gallons 20% iron control HCL acid. Swabbed. Shut well in.

10-18-2000 - Swabbed. Shut well in.
