This well is presently completed in Morrow Sand @ 8435-8472 and production declining rapidly We propose to set a standing valve in packer @ 8418 KB load hole w/KCL water, unlatch tubing from on/off tool and POOH. Rerun tubing conveyed gun and new packer and perforate new Morrow pay at 8330-8342. If needed will stimulate and return well to production.
