We TD'd this well at 4500' on 7-9-93. On 7-10-93, we set 4491' of 5 1/2", 15.5 ppf, J-55 production casing in a 7 7/8" open hole. The casing was cemented to surface with the following cement slurries:

550 sx LITE (35:65) + 6% gel + 10% salt + 1/4 lb/sk Cello-seal
560 sx Class "C" + 0.3% dispersant + 3% salt + 1/4 lb/sk Cello-seal

We circulated 149 sx cement to the pit. Curenly, we are waiting on completion.
