Set 3rd plug in 8-3/4" hole @ 1,475' with 120 sks. Class C + CaCl<sub>2</sub> mixed @ 14.8 lbs./gal & 1.32 cu.ft./sk.  
Tagged 3rd plug @ 1,260' with 15,000 lbs. string weight.

Set 4th plug inside 9-5/8" casing from 40' to surface with 25 sks. Class C.

Installed dry hole marker as required.

Note: 1,395' of 9-5/8" surface casing & 40' of 20" conductor remain in well.
