DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Before deepening total depth of hole was 1415'. Hole was deepened to T.D. 1473 with an increase in oil from 1423-29 1/2'. Dry sand was drilled from 1440 to 1473 and 7 sacks of cement was placed on bottom to plug back hole from 1473 to 1440. On an 8 hr test the well pumped at the rate of 5 bfpd, 8% water. Prior to deepening the well was pumping 50 bfpd 50% water.
