1. Pull out of hole with the tubing.
2. Set C.I.B.P. at 6,400'.
3. Ran in hole with tubing. Set 25 sack plug from 6,400' to 6,050'. *
4. Set 25 sack plug from 2,650' to 2,300'. This covered the top of the Delaware at 2,600' and the 8 5/8" casing shoe at 2,503'.
5. Set a 25 sack plug from 1,350' to 1,000'. WOC for 4 hours. Tag top of cement at 990'.
6. Set 25 sack plug from 600' to 250'. This covered the 13 3/8" casing shoe at 422'.
7. set marker in 10 sacks of cement.

* This covered the top of the Bone Spring at 6,350'.
