At 2200 hours on 6-16-93, we, spudded this new well. On 6-19-93, we set 855' of 13 3/8", 54.5 ppf, J-55 surface casing in a 17 1/2" open hole. The casing was cemented to surface with the following cement slurries:

- 600 sx LITE (35:65:6) + 2% CaCl2 + 1/4 lb/sk cellophane flakes
- 200 sx Class "C" + 2% CaCl2 + 1/4 lb/sk cellophane flakes

We circulated 41 sacks of cement to surface.
