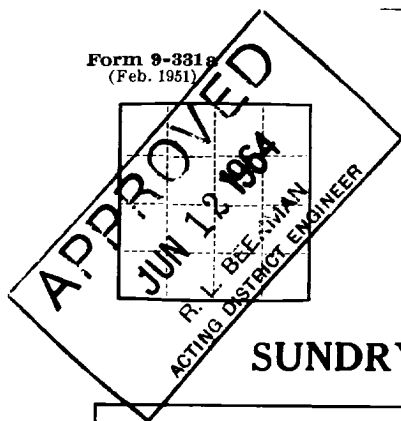

DETAILS OF WORK

We received verbal approval to plug well December 5, 1962, from Mr. J. A. Knaut, District Engineer for USGS in Artesia, New Mexico. TD 4,000'. We used 10 # sand in plugging operations and set the following cement plugs: 50 sks from 3,800' to 4,000' TD; 30 sks from 2,200' to 2,325'; 20 sks from 1,000' to 1,100'; and 15 sks from surface to 75'. We left 1,050' of 7" - 17 # surface casing in the hole. The sand pits have been filled, location cleared of junk, location levelled and location properly marked.

This location is ready for inspection by the USGS.
