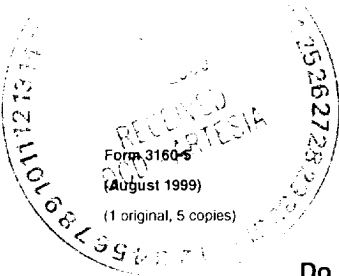

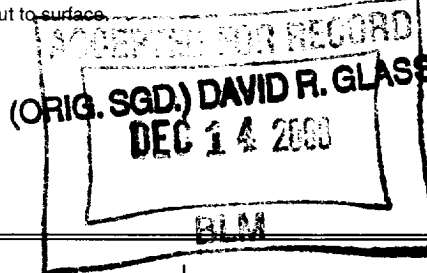

WOC 20.5 hrs. Tested csg to 500#, OK. Circulated cmt to 75'. Topped out to surface.
