1. Drill 25" hole to 40'. Set 40' of 20" conductor cement with Redi-mix cement to surface.
2. Drill 17½" hole to 500'. Run and set 500' of 13 3/8" 48# H-40 ST&C casing. Cement with 550 Sx. Class "C" + 2% CaCl, circulate cement to surface. WOC - 18 hours
3. Drill 12½" hole to 1700'. Run and set 1700' of 8 5/8" 24# J-55 ST&C casing. Cement with 600 Sx Class "C" Light cement + additives, tail in with 400 Sx. Class "C" + 2% CaCl, circulate cement to surface.
4. Drill 7 7/8" hole to 5500'. Run and set 5500' of 5½" 17# J-55 ST&C casing. Cement with 250 Sx. Class "H" cement + additives, top of cement estimated at 4000'.
