Describe Cause of Problem and Remedial Action Taken.*
While excavating for new construction, HEP discovered discolored soil with a hydrocarbon odor. Safety and Environmental Solutions (SESI) was contacted to sample and delineate. SESI mobilized onsite on 11/19/15 with Geoprobe to collect core samples for analysis. Six samples were taken from four boreholes. Results show BTEX from 0.645 to 10.8 mg/kg and TPH from 1,210 to 11,565 mg/kg. No benzene was detected and most TPH was in the diesel range.

Describe Area Affected and Cleanup Action Taken.*
The area observed as being affected is a dirt rectangle 60 ft. x 7 ft. The current owner, HEP Holly Frontier, only loads asphalt in this area but the previous operator reportedly loaded diesel and naphtha at this location. Because concrete and caliche prevented complete delineation, SESI will prepare a work plan for submittal to OCD to more completely delineate the area affected.
