Mr. Keyes:

ConocoPhillips (CoP) has retained Basin Environmental Service Technologies to address potential environmental concerns at the above-referenced site.

Background and Previous Work

The site is located approximately 3.6 miles southeast of Maljamar, New Mexico at UL/A sec. 26 T17S R32E. NM OSE, BLM and Basin installed monitor well records indicate that groundwater will likely be encountered at a depth of approximately 69 +/- feet.

On February 24th, 2015, CoP discovered a stuffing box leak during normal rounds. A total of 5.1 barrels of oil and 5.1 barrels of produced water was released over 590 sq ft of caliche pad with 5 barrels of oil and 5 barrels of produced water recovered. BLM and NMOCD were notified of the release on February 25th, 2015, and an initial C-141 was submitted to both parties the same day. NMOCD approved the initial C-141 on February 25th, 2015 (Appendix A).

On December 16th, 2015, Basin personnel were on site to assess the release. Two points within the release area were sampled with depth (Figure 1). All samples were field tested for chlorides and organic vapors, and representative samples were taken to a commercial laboratory for analysis (Appendix B).

Photo Documentation of these activities may be found in Appendix C.

Corrective Action Plan

Based on the assessment, the release will be scraped down to 6 inches bgs. All excavated soil will be taken to a NMOCD approved facility for disposal. Clean soil will be imported to the site to serve as backfill. A sample of the backfill soil will be taken to a commercial laboratory to confirm that the chloride reading is below regulatory standards. The lease pad will be backfilled with clean, imported caliche. The site will be contoured to the surrounding location.

Once these activities have been completed, a report will be sent to NMOCD and BLM requesting 'remediation termination' and site closure.
