2" ball valve busted causing a 44 bbl produced water and oil to release into unlined containment. Well was immediately shut in to prevent further release. Repairs on the ball valve will be made.

**Describe Area Affected and Cleanup Action Taken.\***  
27 bbls produced water and 17 bbls oil was released on the South, South West side of the facility. 6 bbls oil was recovered via vacuum truck. Size of affected area was 5'x48'. All released fluid remained on location. Environmental Agency to be contacted for remediation.
