Thank you for the information. Are these two piles of soil still in place? Do you know the status of the liner integrity? I am asking because the BTEX, TPH, and chloride levels at 2 ft., indicated on the map, are very much above permissible levels. These piles either need to be removed to a NMOCD-approved landfill and bottom levels determined.
