I would like an update on the status of the full site delineation that has been requested of Sundown for the State P facility that is listed below.

In addition, it appears that Sundown has had a new release at the Lovington #1 well, API #30-025-05398. You will need to submit an initial C-141 to both NMOCD and myself for this release. It is evident that some scraping has been done, however due to the amount of staining still on the pad as seen in photo #013 (also showing oil running down the lease road), I believe a C-141 is warranted. Please also mention the area of overspray in the pasture (photo #16), and I would also like to request representative soil sampling of that area as well.

Also shown in photo #017, is an old pipeline release on the line running south of your pumpjack. I will defer to NMOCD on whether this will need its own C-141 or if it can be included with the well release, but either way it will definitely need a full delineation and work plan submitted.
