Is this delineation workplan only for 1RP-4705? Please be advised that NMOCD allows a corrective action plan to encompass multiple 1RPs if informed and approved in advance.

NMOCD approves of the proposed additional delineation plan for 1RP-4705. Permissible levels of 250 mg/kg chlorides must be obtained and maintained for 10 ft. further in depth. BTEX and TPH permissible levels must be obtained and maintained for a minimum of 2 ft. further in depth. All laboratory analyses must have accompanying field data. Please note that if GW impact is anticipated, one or more temporary GW monitoring wells may be required within the impacted area.
