Per your email dated July 25, 2017, 4 confirmatory sidewall samples were collected on July 27, 2017, from each of the over excavated areas at DS-3 and DS-7 locations and confirmation bottom samples were previously collected from the same areas on June 22, 2017. Review of all delineation and confirmation sample results indicates BTEX and TPH concentrations are below RRAL's determined for the Site and GHD requests the NMOCD's permissions to backfill the scraped/excavated areas. The reason for requesting approval to backfill at this time is so that Plains' groundwater remediation system can be brought back into operation shortly after backfilling & restoration activities are completed. Attached is Figure 3 which depicts the scraped/over excavated areas, delineation & confirmation sample locations, collection dates, depths, and analytical results.

Prior to backfilling activities, the landowner will be contacted for backfill material and restoration requirements. Subsequent to backfilling and restoration, a concise remediation report consisting of site activities, detailed figures, tables, photos, analytical results, and a request for closure will be submitted.

Via this email, I am requesting permission to backfill the remediated release area excavation located at the Plains-Darr Angell #2 Groundwater Remediation project site (Site) located in Lea County, NM. The Site is located on rural private land, owned by Mr. Darr Angell, in Section 11 (Unit O) and 14 (Unit B), Township 15 South, Range 37 East and the geographical coordinates are 33.024° N, 103.167° W. The depth to groundwater at the Site is approximately 65 feet below ground surface (bgs) which gives the Site a Total Ranking of 10 - 19. In addition, I am also requesting that no further action is required in regards to the release area for the closure report and project file.

On May 24, 2017, delineation soil sampling within the release area was conducted subsequent to removal of impacted soil. Analytical results indicated the TPH from DS-3 and DS-7 remained above the New Mexico Oil Conservation Division's (NMOCD) Recommended Remediation Action Levels (RRALs). On June 22, 2017, confirmation soil sampling was conducted subsequent to further removal of impacted soil in the areas of DS-3 & DS-7 sample locations. Analytical results indicated the TPH from DS-3 and DS-7 were well below RRALs. For both events, a total of approximately 60 yards of crude oil impacted soil were removed and stockpiled on plastic at the Site. Attached is a Topographic Map depicting the Site's location, an Aerial Image depicting the Site, a Detailed Site Map depicting sample locations/depths/soil analytical results, and analytical data table.

Upon your approvals, Darr Angell will be contacted so he can view the Site prior to backfilling, to determine the location of backfill material provided by him, and his restoration requirements.
