Amber:

Just to keep you in the loop, notes from the conference call this morning, 13 June 2017, with Linn and Diversified. 1RP-2772 and 1RP-3390 are in separate locations. Diversified will submit 2 separate reports with maps and additional data.

#### 1RP-2772

- Diversified found the monitoring well indicated by Hungry Horse in the 2015 document, but no records of groundwater monitoring data were found.
- GW from the well will be sampled and analyzed with Method 8260 and 300. Depth to GW will also be noted.
- Surface impact will be evaluated after GW results assessed (i.e., if additional monitoring wells are needed due to impacted GW).

Additionally, they will make the attempt to find well bottom and note the depth, also will do an OSE search and see if well and allied information with paperwork was sent to OSE. No survey yet, will attend this if GW has been impacted. If impacted they know more wells, etc will be needed.

#### 1RP-3390

- Diversified will get confirmatory samples from 4 ft. bgs in several locations in the impacted pasture and 1 or 2 ft. bgs from the pad.
- Sample locations will be marked on a scaled map.
- Mike Burton will contact you about current vegetation status and revegetation requirements.

Based on approvals from Tomas, we will cross reference what they left in place post excavation. Also, they will create a scaled map that identifies both know releases and associated footprint thereof.
