Mr. Wooten,

The Oil Conservation Division (OCD) has reviewed the *Stage 1 Abatement Plan* submitted on behalf of Chesapeake by BBC International, Inc. dated August of 2007 along with the *Stage 1 Abatement Report* and *Stage 2 Abatement Plan* submitted on your behalf by ARCADIS US, Inc. both dated March of 2012, all in regards to the above-referenced release site.

The OCD finds the *Stage 1 Abatement Plan* of 2007 administratively complete. While that plan was never formally approved by the OCD, Chesapeake nonetheless did fulfill the public notice requirements under the oil and gas regulations (19.15.30.15.A NMAC) and the field effort did characterize the magnitude and extents of soil and groundwater contamination to a significant degree. As such, the OCD does accept the findings of the *Stage 1 Abatement Report* of 2012.

Furthermore, the OCD has determined the *Stage 2 Abatement Plan* of 2012 is administratively complete. Chesapeake should proceed with public notice of the Stage 2 plan as required under 19.15.30.15.A and B NMAC. The wording of that notice must be pre-approved by the division.
