NMOCD will consider vertical delineation completed for 1RP-4651, with the exception of area represented by the West Trench. Please address these concerns regarding the proposed remedial activities:

- Given the elevated TPH levels in the soil of the proposed area for excavation, soil blending is not permitted unless a scheduled resampling or monitoring plan is proposed.
- For the areas represented by Trench 1 and Trench 2, the proposed remedial action is accepted. Minimum of 3 confirmation samples at the edges of the impacted area are required to complete release characterization.
- For the area represented by Trench 3, a minimum of 1 confirmation bottom and 3 edge samples (border with Trench 2 area and North and South edges) are required.
- For the areas represented by Trench 4 and West Trench, the bottom confirmation samples for the proposed 6 ft. excavation area must demonstrate permissible levels of BTEX, TPH, and chlorides. If not, proceed to excavate to the next feet. Confirmation sidewall samples must be taken from all 4 sides.
- A scaled map with the locations of the confirmation samples demarcated is required.
- NMOCD requires all confirmation samples be discrete.
