Mr. Hitchcock:

NMOCD will consider delineation completed for 1RP-4853. The proposed remediation is approved with these stipulations:

1. The soil temperature of the samples collected on December 13, 2017 are not acceptable according to EPA methodology. Resample and submit for laboratory analyses (TPH extended and BTEX) the surface samples of the area represented by T2.
2. For the proposed 1 ft. excavation of the area represented by T1, edge and bottom confirmation samples must demonstrate permissible levels of TPH extended (≤ 5000 mg/kg) and chlorides (≤ 600 mg/kg).
3. On an appropriately scaled map, demarcate the area with 1 ft. excavation and mark the confirmation sample locations with GPS coordinates.
4. Provide dated photo documentation of delineation and remediation activities.
