Olivia,

Yes, we have three open incidents at the same Atha disposal but different locations. Souder Miller is the contractor managing remediation of the three incidents and Austin Weyant is project manager for those.

1RP-4547 was a release on the lease road probably 0.1-0.2 miles west to the entrance.

1RP-4571 and the new one 1RP-4592 are on the same spot. This one is located right behind the tank battery pad. It is on the north west corner outside the pad.

We completed delineation for RP-4547 and the contractor is working on the work plan.

We will merge work for incidents 4571 and 4592 as they are exactly on the same spot. Delineation will be completed next week approximate on Wednesday 02/15 to wait 811 clearance.

They will be submitting work plans for both incidents on our behalf before the end of this month.
