Attached please find the Data Table with the Confirmation Samples (CS) analysis and GPS Coordinates for the above referenced project, along with an updated Site Map indicating the sample locations. I've broken out the site map into 3 areas to enlarge for easier viewing. I've also attached the full laboratory results to compare with the information in the table.

Lime Rock Resources respectively request permission to begin backfilling so we can bring this matter to a close as soon as possible. All the confirmation samples for the sidewalls and bottom of the B-4 excavation are below the RRAL's limit of 600 mg/kg. We will be stockpiling topsoil in the area of B-4 (in purple) starting either tomorrow 2/9/2018 or Monday 2/12/2018.

Due to encountering rock, we were unable to reach total depth of the excavation in the area of B-1, B-2 and B-3. The area surrounding B-1 (in green) was excavated to depths between 2-feet and 2.5-feet deep. The NMOCD's approved work plan stated

this area was to be excavated a depth of 3-feet deep. The area around B-2 and B-3 (in red) was excavated to depths between 2.5-feet and 3.5-feet deep. The NMOCD's approved work plan stated this area was to be excavated a depth of 4-feet deep.

Per our onsite meeting, it was required to collect Bottom Samples (BS) from the open excavation, where depths were not reached, to indicated the total chlorides being left in place, under the 20 mil liner. The results from these samples are on Page 2 of the Data Table along with their GPS Coordinates and at what depth rock was hit.

We will place visible markers indicating the edges of the liner after the remediation is complete. This is to ensure that anyone doing work out in this area will be aware that the liner is less than 4-feet deep. The maker will have the company information, a phone number and the depth of the liner.

Written documentation regarding the field visit on January 25, 2018, at the NVANU #73 site, still has not been received. These are the information that NMOCD requires for approval of the revised excavation depth from 4 ft. bgs to more shallow and variable depths for 1RP-4880:

- Affirmation statement attesting that deeper removal is not feasible with either a back or trackhoe and that the properly keyed minimal 20 mil liner will be cushioned to maintain integrity.
- Representative confirmatory bottom samples from maximum depths achieved for each of the excavated areas. Sidewalls will be required at no greater than 50 ft. apart.
- Highly visible markers, similar to those used for pipeline identification, at the edges of each area with contact information. This is to ensure that a pipeline operator will not encounter and damage the liner at less than 4 ft. bgs.
