Noted. NMOCD approves of the revised proposed remediation of 4 ft. excavation and properly keyed 20 mil liner for the entire release area for 1RP-4710 with these stipulations:

- Confirmation sidewall samples no greater than 50 ft. apart.
- On an appropriately scaled map, demarcate lined area and confirmation sample locations with GPS coordinates.
- Dated and labelled photo documentation of remedial activities.

Based on the data provided and aerial imagery of the impacted area, a 4 ft. excavation of the entire release area with a minimal 20-mil liner is feasible and required.
