Transfer Pump failed to shut off on low side shut down at one of the production facilities, sending a volume of oil to the inlet storage tank at the recycling facility, overflowing the tank and releasing the oil into the containment area.

Describe Area Affected and Cleanup Action Taken.\*

All fluid was contained in the lined containment area at the recycling facility. Therefore, all fluid release was recovered. Liner is only a year old so it has integrity protecting any soil from being impacted. Containment has been pressure washed and is cleaned up. I have attached 2 recent pictures with date stamp for verification purposes. McElvain is respectfully requesting closure for this release.
