COG Operating, LLC (COG) is pleased to submit for your consideration the following remediation work plan for the Stealth Federal Com #004H. This plan is in response to an oil release that occurred on December 23, 2017. Subsequent to the release a C-141 initial report was approved by the New Mexico Oil Conservation Division (NMOCD) on December 27, 2018

BACKGROUND

The Stealth Federal Com #004H release is located in Unit Letter P, Section 17, Township 19 South and Range 32 East in Lea County, New Mexico. More specifically the latitude and longitude for this release are 32.65407565 North and -103.7828455 West.

On December 23, 2017, freezing caused the loss of supply gas to the FWKO pneumatic dumps with resulted in approximately eight-teen (18) barrels (bbls) of oil to spray from the flare. The overspray impacted the battery, location, and pasture. A vacuum truck was able to recover approximately twelve (12) bbls of oil. As part of initial response activities overspray residue was removed from the tanks and production equipment and the impacted area was treated with Micro-Blazed.

On February 8, 2018, a site assessment and soil sampling were conducted in order to define the impacted area. A site diagram is included in Appendix I. The analytical results from the soil sampling activities are summarized in the table below.

GROUNDWATER AND SITE RANKING

According to the New Mexico Office of the State Engineer (NMOSE) groundwater in the project vicinity is approximately three-hundred and forty-five (345) feet below ground surface (BGS) (Appendix II). No water well or surface water was observed within one-thousand (1,000) feet of the release site. Therefore the site ranking for this release is zero (0) based on the following:

Depth to groundwater	>100-feet

PROPOSED REMEDIAL ACTIONS

- The impacted area in the vicinity of sample locations T-3, T-4, and T-5 will be excavated to a depth of one (1) foot BGS.
- Sidewall samples will be taken from the excavation in all four cardinal directions and analyzed for TPH and Total Chlorides to confirm that all of the impacted soil above the NMOCD Recommended Remedial Action Levels (RRAL's) has been removed. The impacted area is fully vertically delineated therefore confirmation samples will not be taken at the bottom of the excavation.
- The excavated material will be hauled to an NMOCD approved solid waste disposal facility.
- Upon receipt of acceptable analytical results from the sidewall confirmation sampling the excavation will be backfilled with caliche and contoured to match the surrounding location.

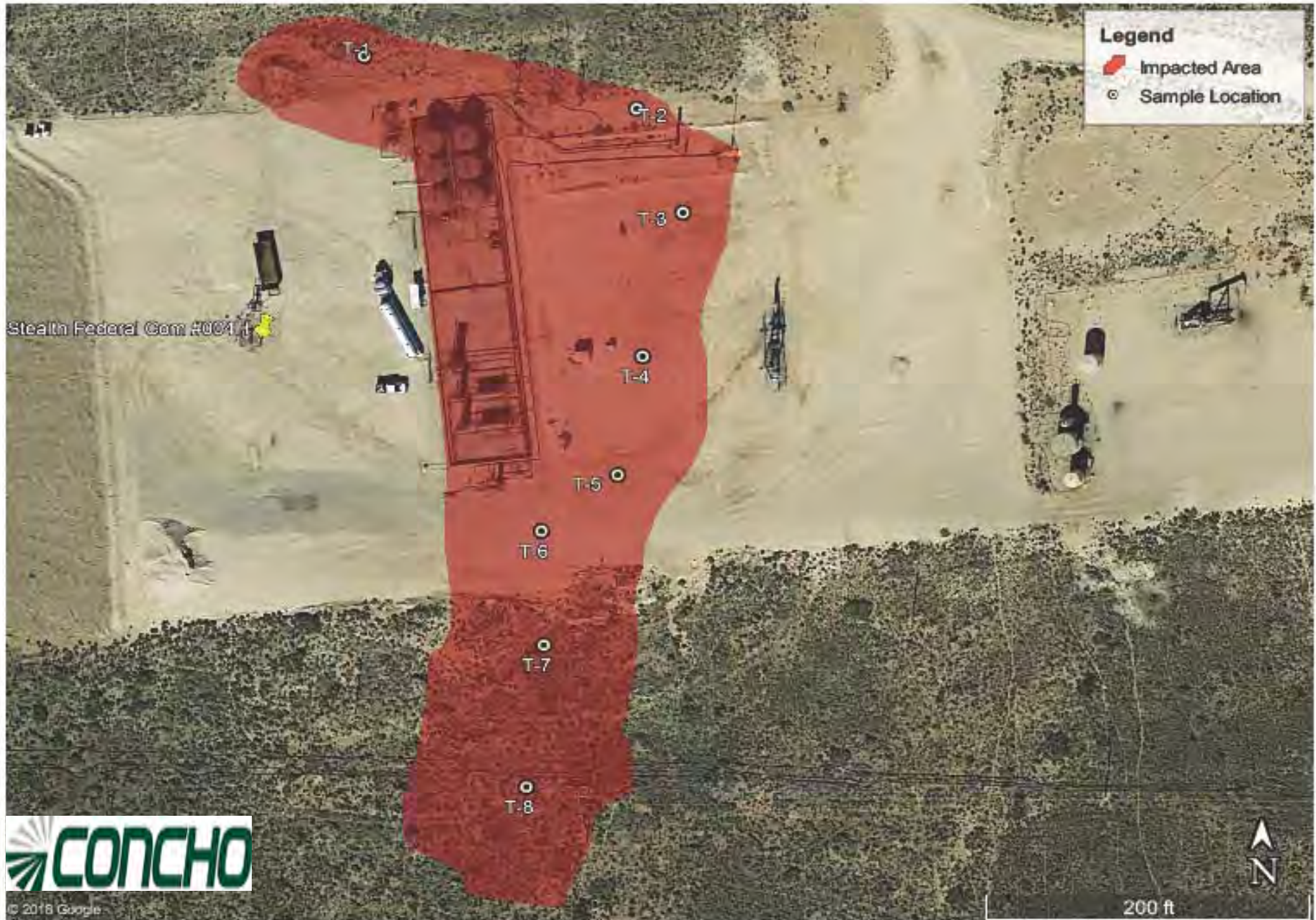

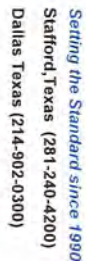
