NMOCD approves of the delineation completed for 1RP-4904 and the proposed remediation with these clarifications:

1. Sidewall confirmation samples taken in the impacted pasture area must be no greater than 75 ft. apart.
2. On an appropriately scaled map (or tabulate), demarcate confirmation sample locations with GPS coordinates.
3. Include dated photo documentation of delineation and remediation in the subsequent report.

Like approval from BLM required.
