Mr. Brandon:

Thank you for the verification. Noted. I assumed that the orientation was incorrect as well. Due to the age of the release for 1RP-3378, NMOCD requests that permissible chloride levels of 600 mg/kg be obtained and maintained for at least 5 ft. further in depth at sample locations 1, 3, and 4. All laboratory analyses should have accompanying field data.

Please be advised that NMOCD will defer complete review of the assessment report submitted on 13 November 2017 until the completion of delineation. In the subsequent report, please demarcate GPS coordinates for the recent sample locations and the original locations in 2011 on an appropriately scaled map.

NMOCD requests at least 48 hours notification in advance of soil sampling activities.
