On March 20, 2017 a leak was found on the MCA 67 from the casing on this well. It resulted in the release of 58.5 bbls. Of produced water with 55 bbls. Recovered. Covering approximately 31,000 square feet of COPC and COG pad area. Immediate action by COPC was to dig out all visibly wet contaminated material and dispose of contaminated material at an approved disposal. This resulted in approximately 1' of material being removed from location. Samples were taken on February 9th 2018 at 5 different spots (see attached map). Samples were all tested for chlorides and to 3' were tested for TPH and Btex for verification. Samples were sent to cardinal Lab. COPC proposes digging out an additional 6" or until clean (below 600ppm chlorides) in the sample #2, #3 and #4 areas (out lined in blue and green). This material will be disposed of at an approved disposal. We will then dig an additional 2.5' out in the area around #3 and #4 (outlined in blue) and put down a 40 mil plastic liner. The material dug out from around area #3 and #4 will be stockpiled and we sample every 50 yds. Of stockpiled soil and get lab verification to assure it is below 600 ppm chlorides and we will reuse this material as backfill on top of the liner. We will pull wall samples of the dug out area for lab verification that we have dug out all contaminated area horizontally. We will then backfill entire area with a clean base coarse. Please see attached map for planned excavation areas and depths.

3) On a scaled map, outline area with properly keyed liner; mark release point and confirmation sample locations with GPS coordinates; and annotate areas with differing depths of excavation (or no excavation required).
