BLM **accepts** your proposal with the following stipulation: The impacted are will need to be reseeded with approved BLM seed mix, during appropriate planting window.

Like approval from the NMOCD is required.

EA NOTES:

1. The release point did not impact any known archaeological area.
2. The point of release occurred off location but is covered under a PA survey, no additional surveys will be required.
3. This area is located within a low cave/karst zone.
4. You are cleared of flood zones, active playas, streams, etc.
5. Area is noted to be within 0-3% slope.
6. Soils are within the JAL/Drake series.
7. There are no T&E species noted (animal or vegetative) within this area.
8. Site is not located within any Special Area of concern.
9. Site is not located within a RMP ACEC.

NOTE: LPC Timing Stipulations are in effect - from March 1st through June 15th. Please plan remedial activities accordingly. Check for African Rue...treat (before it gets out of control).
