Also, the extent of the release area needs to be demarcated on a scaled map. Details are in the directive appended to the reviewed initial C-141 form.

What are the proposed remediation plan for these releases? Please be advised that all remedial activities are considered conducted at risk if release characterization/delineation workplans were not approved by NMOCD.
