Please be advised that since this release occur within town, please obtain and maintain permissible chloride levels (600 mg/kg) for 5 ft. further in depth for complete vertical delineation. For Benzene, BTEX, and TPH extended, 1-2 ft. further in depth is sufficient.

NMOCD will agree to the proposed delineation plan for 1RP-5025 with these conditions:

- 1. On a scaled map (or tabulated), provide GPS coordinates of vertical and horizontal delineation sample locations.
- 2. Delineation sample locations must be no greater than 50 ft. apart.
- 3. Tabulate laboratory data with corresponding data from field tests, along with sample IDs and depths of samples.
